## Resources for helping establish a U.S. National Human Rights Institution (NHRI)

The United States is among the only democratic states yet to follow international commitments and guidelines calling for the creation of a national institution to coordinate and guide human rights implementation. Allies, UN member peers, and UN expert panels have repeatedly called on the U.S. government to create an NHRI, as has a growing chorus of civil society organizations. There are new possibilities to make progress toward this important goal under the Biden administration.
