

• The UPR Process was launched by the United Nations General Assembly in 2006 to provide for periodic examination of the human rights performance of all 193 UN Member States. It represents a significant strengthening of international human rights procedures. (More info.)

UPR Cities Project

Organizers in cities across the United States will mobilize local consultations to assess the state of human rights in their communities. They will identify both achievements and pitfalls & generate and promote specific recommendations for both local and national authorities to strengthen human rights in the United States.





- Open, wide-ranging discussion on key human rights issues
- Drafting of observations, recommendations, or suggestions for UPR Shadow Report for the U.S Review in 2020.
 - In other words, what should the U.S. continue to do or do differently?
- Raise awareness about both human rights and critical role of civil society in UPR process

Consultation Objectives

UPR Cities USA-"The 3 Cs":

Steps for organizing local UPR Cities & Communities

1) Collect local testimony about human rights.

- Interview residents or convene consultations with diverse/intersectional groups & residents about human rights issues in your community (i.e., meetings, collecting testimony, surveys, public forums, etc.)
- Work with Local Human Rights/Human Relations Commissions + govt. allies
- 2) Compile summary reports of local human rights conditions. Name key problems/challenges as well as positives/progress. Use this to report to local officials and press for local responses.
 - Deadline is Sept. 15, 2019 for submissions for national stakeholder report.
 - Local review processes can continue through 2019 & 2020
- 3) Clamor! Publicize the final UPR report and press local governments to implement recommendations. (September 2020)

Strategic Advantages of UPR for Local Organizing

- <u>Comprehensive</u> review of national human rights recordsnot just specific treaties or issues
- Promotes analysis of <u>interconnected and indivisible</u> <u>nature of human rights</u> (and links treaties & other international mechanisms)
- Encourages <u>creative recommendations</u> for addressing complex intersectional policies.
- Broadens <u>public participation</u> in human rights enforcement.

UPR Reports can draw from a wealth of international human rights instruments

Treaty Bodies & International Observances

The United States has ratified the following international human rights treaties, which makes the US government subject to periodic reviews of its performance. <u>The US Human Rights Network</u> helps support and link grassroots efforts to report on local human rights practices and to hold public officials accountable to international commitments. Treaty Bodies have made a number of recommendations to the US regarding supporting state and local human rights implementation.

Sample recommendations from 2015 UN UPR Report to US

- "Expedite the ratification of the Convention on the Rights of the Child"
- "Pass legislation ... to prohibit ... life imprisonment without the possibility of parole on offenders who were children at the time of offending"
- "Pass legislation to ensure women receive equal pay for equal work"
- "Strengthen human rights education programmes and training for all civil servants, particularly for law enforcement and immigration officers, and combat impunity concerning abuses against defenceless persons"
- "Create a national human rights institution"

Sample Press Release & recommendations on political prisoners

<u>Here's an example of a press statement released by groups working to free</u> <u>COINTELPRO prisoners</u> to encourage action during the first UPR review of the United States in 2010. These claims still remain relevant in this third UPR review.

"The report recommends the United States follows the example of UN member states Germany, France, and Spain by immediately and unconditionally releasing all U.S. Political Prisoners/Prisoners of War [...and] initiate criminal investigations into the conspiracy to commit murder and the murder of political activists targeted by COINTELPRO.

In compliance with its human rights obligations, the United States must adopt measures to ensure the right of political prisoners/prisoners of war to seek just and adequate reparation to redress acts of racism, racial discrimination, xenophobia and related intolerance, and to design effective measures to prevent repetition of such acts."

Example/Proposal UPR Cities USA-2019– Proposal Draft *Human Rights Vs. Corporate Power*

The US government take concrete steps to hold corporations accountable for human rights obligations. Specifically, the US government should:

- 1. Heed the <u>recent letter shared by the UN Special Rapporteur on the</u> <u>right to housing</u> to counter the trend of speculation and growing commodification of housing. **Local governments** should ensure that local policies are consistent with the legal analyses in this letter.
- 2. End privatization of basic needs provision such as water, energy, transit, health care, & banking, and support remunicipalization of public services;
 - <u>Remunicipalisation of public services in Europe</u> (Public Services Int'l, 2011)
 - <u>Here to stay: Water remunicipalisation as a global trend</u> (Transnational Institute, 2015)

UPR Cities USA-2019– Proposal Draft Human Rights Vs. Corporate Power

Proposal to emphasize in our UPR Cities stakeholder/shadow report the recommendation that the **US government take concrete steps to hold corporations accountable for human rights obligations**. Specifically, the US government should:

- **3. Implement the <u>Ruggie Principles</u>** framework on business & human rights (proposed to UN Human Rights Council, June 2008)
- 4. Adopt, without delay, the <u>Accountable Capitalism Act</u> (S.3348) or similar legislation aimed at curbing corporate abuses of human rights.
- 5. Ratify the <u>Draft treaty to regulate</u>, in international human rights law, the activities of transnational corporations and other business enterprises. Local governments should also be encouraged to pass local ordinances based on this treaty;
